# AN ORDINANCE TO REGULATE THE KEEPING AND DISPOSAL OF GARBAGE AND RUBBISH IN THE TOWN OF SHERRY, WOOD COUNTY, WISCONSIN

The Town Board of the Town of Sherry, Wood County, Wisconsin, do Ordain:

### Section 1. Keeping and Disposal of Garbage:

It shall be unlawful for any person to deposit, throw or place any garbage on or within any public street, road, alley, sidewalk or other public place, except the Town Sanitary fill, or within or upon any private property or premises whether owned, kept or controlled by such person or not. All garbage kept by any person pending disposal in the Town Sanitary fill area or otherwise shall be placed and kept in sanitary, metal, covered containers. Section 2. Disposal of Rubbish:

It shall be unlawful for any person to deposit, throw or place any rubbish on or within any public street, road, alley, park, sidewalk or other public place, except the Town Sanitary fill, or within or upon any private property or premises without the owner's consent.

### Section 3. Definitions:

- (1) "Garbage" shall mean and include all cans, bottles, crockery, glass, and all kinds of organic waste resulting from the preparation, use, cooking, handling, dealing in or storing of meats, fish, fowl or vegetables, and all decayed or spoiled organic matter from any source whatever.
- (2) "Rubbish" shall mean and include ashes, paper, rags, garden refuse, grass, clippings, leaves, brush or tree trimmings and all other items of a similar nature, but does not include trees, earth, concrete or stones.

## Section 4. Dumping, Disposal or Deposit of Wastes from Milk Processing Plants:

In addition to the disposal permitted by the foregoing sections hereof, the dumping, disposal or deposit of wastes from milk processing plants may be permitted within the Town of Sherry provided the same does not violate any state law and is not contrary to the best interests of the Town of Sherry or injurious to the health, welfare and best interests of the inhabitants of the Town of Sherry. Any person desiring to dump, dispose of or deposit wastes from milk processing plants shall first make application for permit therefor to the Town Board and shall provide adequate assurance to the Town Board that such dumping, disposal of or deposit of wastes will not be contrary to the best interests of the Town of Sherry or injurious to the health, welfare and best interests of the inhabitants of the Town of Sherry. Upon such showing the Town Board shall grant a permit therefor subject to review, modification or revocation in the event such dumping, disposal of or deposit of wastes shall subsequently become contrary to the best interests of the Town of Sherry or injurious to the health, welfare and best interests of the inhabitants of the Town of Sherry.

#### Section 5. Penalty:

Any person or persons who shall violate any of the provisions of this ordinance or fail to comply therewith, shall, upon conviction, be subject to a forfeiture of not more than \$100.00 and the costs of prosecution, and in default of immediate payment of such forfeiture and costs, such person or persons shall be committed to the County Jail until such forfeiture and costs are paid, but not to exceed thirty (30) days.

This Ordinance shall take effect and be in force from and after its passage and publication.
