NOTICE OF SPECIAL TOWN MEETING
OF THE ELECTORS OF THE
TOWN OF SHERRY, WOOD COUNTY

Notice is hereby given of a special town meeting of the electors of the Town of Sherry on Tuesday, November 15, 2016. This special town meeting will follow the completion of the Public Hearing on the proposed 2017 town budget, which begins at 6:30 p.m. at the Sherry Town Hall, 9285 Second St., Milladore. This special town meeting of the electors is called pursuant to Sec. 60.12(1)(b) of Wis. Statutes by the town board for the following purposes:

1. To establish the compensation for elected town officials for the next term of office pursuant to Section 60.10(1)(b)(1) of Wisconsin Statutes.
2. To authorize the town board to hire the town officers as employees of the town and set an hourly wage pursuant to Sec. 60.10(1)(g) of Wis. Statutes.
3. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specially a proposed tax levy which would exceed the allowable town tax levy for 2016 by 30.132 percent which would be a dollar increase of \$58,550.
4. To approve the 2016 total tax levy to be collected in 2017 pursuant to s. 60.10(1)(a) of Wis. Statutes.
